### Electronic funds transfer (EFT) enrollment

Electronic claims payment through EFT is a secure and fast way to receive payment, reducing administrative processes. EFT deposits are assigned a trace number that is matched to the 835 electronic remittance advice (ERA) for simple payment reconciliation.

As of November 1, 2021, use <https://provider.simplyhealthcareplans.com/florida-provider/electronic-data-interchange> to register and manage EFT account changes.

### Electronic remittance advice (ERA) enrollment

Go to <https://www.availity.com> and select **Enrollments Center** in the *My Account Dashboard* on the home page. Select **ERA Enrollment** in the *Multi-Payer Enrollments* section. Then, simply follow the wizard and submit. After submitting, you will be notified by email that enrollment is complete and will start receiving 835s through Availity.
